Following the last meeting the Council wrote to Mr Phillip Cresswell thanking him for his services to the Parish Council in relation to the Local Plan and Cinderhill. Mr Cresswell has responded his own thanks for the very kind letter and said how much it was appreciated.

The Borough Councillor was asked about the maintenance of the Fairview play area which had been decommissioned. It was agreed that the Borough Councillor would ask questions at AVBC and that the Clerk would write to the Chief Executive.

It was reported that although the 'no waiting area' on Highfield Rd was now operational there were still no signs.

Although the Borough Councillor had been hoping to pay and supply 'litter pick rings' his budget for donations had been cut and he doubted there would be enough funds to supply these. He was hoping to donate a percentage of the cost of the Village hall noticeboards.

100/24 Minutes of previous meeting

The minutes were agreed as an accurate record & signed by the Chair.

a) Nature Reserve – update

Quotation in the sum of £129.45 from Brunel Engraving had been received for the plaque to be placed on the bird feeder. Alternative quotes are to be sought.

The perimeter wall was showing signs of cracking it was resolved that the Clerk report to the surveyor and also check the current lease as to who had responsibility for the wall.

b) Pitfield footpath/Footpath 24

No further information.

c) Carol Service - 13th December at 6.30pm

All arrangements in hand & Mayor has confirmed his attendance.

d) Fairview Close - decommissioned play area.

It was resolved that the Clerk write to the Chief Executive of AVBC stating that as the play area was held 'in trust' to the Borough Council they should continue to maintain the area.

e) DCC - land at Toll Bar used as nature reserve.

DCC had been asked for a clause to be inserted into the Agreement that the Parish Council wished to retain the right to purchase in the future.

f) Woodhouse Rd – abandoned house

The owner had informed that work would resume in January 2025.

g) Amber Valley Local Plan - Land north of Denby (Cinderhill) - Member to oversee

As Mr Cresswell was unable to continue with monitoring this matter it was felt necessary that a Member should oversee. Cllrs Riley and Morgan offered, however, it was felt that it should go onto a future agenda to give those absent the opportunity.

h) Remembrance Parade & Service

Email received asking for the service to be made more modern. Following discussion it was unclear as to how the service could be made more modern. Only 10 minutes is allowed at the War Memorial for the service (due to the road closure) therefore this only allows for the Act of Commitment & reading of names.

Mr Hawthorne had been asked to expand his ideas as to how the service could be improved but no response was received. Clerk to respond.

i) War Memorial – flag pole

The Clerk had ascertained that planning permission would be required for a permanent fixture. It was resolved that as this would invite anti social behaviour it was agreed not to proceed. Clerk to reply to resident.
